## **4. FIRST AID MEASURES**

#### Inhalation:

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if breathing problems develop.

#### **Skin Contact:**

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap. Seek medical attention if symptoms occur.

# 6. ACCIDENTAL RELEASE MEASURES

If spill is too large or absorbent material is not avialable create a dyke to stop the spill from spreading. Collect the spilled material and place into a suitable container for disposal. Wash area after spills.

# 7. HANDLING AND STORAGE

## Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. The Australian Acceptable Daily Intake (ADI) for procymidone for a human is 0.03 mg/kg/day, set for the public for daily, lifetime exposure. This is based on the NOEL of 2.5 mg/kg/day, the level determined to show no effects during long term exposure for the most sensitive indicators and the most sensitive species. (Ref: Comm. Dept. of Health and Ageing Office of Chemical Safety, 'ADI List', March 2016).

### **Ecotoxicity:**

Procymidone has low oral toxicity in birds. Procymidone has a low toxicity to bees and earthworms.

Aquatic toxicity: Harmful to aquatic life. Procymidone is moderately toxic to algae, daphnia and some fish.

Persistence and Degradability: Product is biodegradable. It will not accumulate in the soil or water.

#### **Bioaccumulative Potential:**

This product has a low BCF of ~110 - 130. As such no bioconcentration is expected in birds or mammals.
