Farmer Jones orders 10,000L of chemical in December. The price on the day is \$8/L. However, the price keeps coming down to \$7.50/L till he takes delivery in Feb, and then further down to \$7/L at March 30.

The sales order in December shows chemical price at \$8/L. The invoice at delivery shows \$7.50/L. However, a credit is applied on Farmer Jones account after March 30 for the difference of another \$0.50/L. So, Farmer Jones pays \$7/L!

1. The Customer nominates products for purchase from 4Farmers on the following terms:
 - a. A Sales Order will be issued for the customers and nominated distributors records.
 - b. The nominated goods will be invoiced at time of delivery under agreed payment terms unless tailored alternate arrangements are made
 - c. Late payment of accounts will incur a management fee and possibly collector fees if required
 - d. Pricing is applicable only to the nominated products and quantities specified in the agreement
 - e. In the event of a *force majeure** event where supply is impossible or pricing rises by 15% or more, 4Farmers reserves the right to renegotiate supply and pricing
2. The Customer nominates a product specific **“Invoice Now/ Pay Later”** option where:
 - a. This offer will be considered on a case-by-case basis by senior management of 4Farmers Australia only
 - b. Specifically nominated products are invoiced to the client at an agreed price prior to delivery
 - c. These goods are to be paid for prior to a time derived by mutual agreement.
 - d. Notice must be provided to 4Farmers regarding intent to collect with a minimum of 30 days lead time.
 - e. 4Farmers invoice price Guarantee (This guarantees 4Farmers to supply products at best possible price on the day due to market fluctuations)
 - f. In the event of a *force majeure** event where supply is impossible or pricing rises by 15% or more, 4Farmers reserves the right to renegotiate supply and pricing
3. Other than as provided in this Agreement, the General Terms and Conditions of Sale remain in full force and effect.
4. The 4Farmers General Terms and Conditions of Sale are incorporated into this Agreement as if set out in full.
